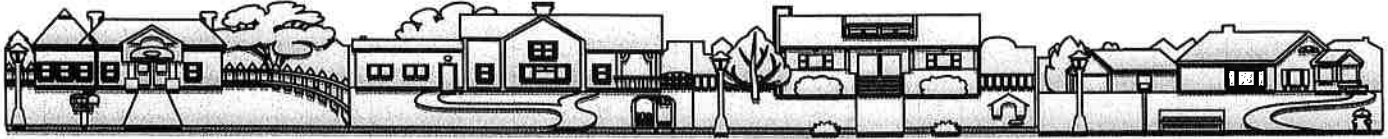

### NOTICE OF COUNTY RECOMMENDATION

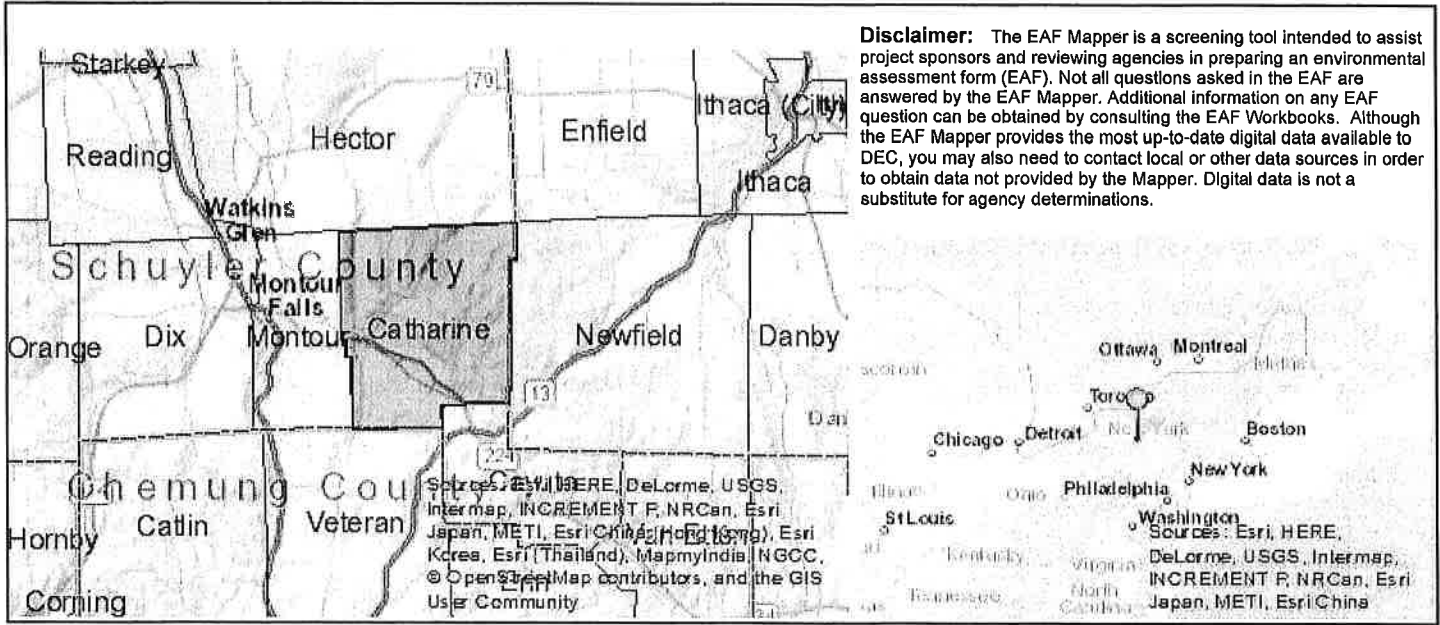
