Highway Superintendent's Report: Marty said they have been doing some plowing & sanding. On January 8th a tanker truck went off Pertl Rd at 1:30am so the guys got called out early to salt

& sand the icey roads. When they're not plowing they are patching, trimming trees and working in the shop. They have 1 truck at Caskey's getting repairs and inspection. Marty said that the excavator that they are looking at is \$214,121.00. The Catapillar dealer lowered our trade value to \$6500 leaving a balance of \$207,921. It was suggested that Marty talk to the salesman to see if they would be willing to give us the \$7500 trade in as originally quoted.

Unfinished Business: Work has not started on the garage renovations. John has reached out to the contractor with no success. John will be sending him a letter to find out what he plans on doing.

New Business: Diane brought up upgrading our phone system and internet. The system we currently have is obsolete and the phones are not serviceable. We received several quotes from Empire Telephone. Diane will contact the representative from Empire Telephone to see if she will attend the March board meeting to give us more information on our options. The town received an estimate for Storage Tank insurance. It was decided that we did not need it as the fuel tank is owned by Wade's/SP Wilson and the propane tanks are owned by Williams Oil. They are both responsible for covering their tanks and spill protection. The town also received a quote for Cyber Security insurance. It was also decided that is was not needed as our main server is checked weekly by SCT Computing Service and all our data is backed up in 3 different locations. Jamee Mack brought up the Procurement Policy stating that it hasn't been updated in several years and it needs to be looked at. After much discussion is was decided that Jamee would get a copy of the Procurement Policy with red lines in areas that need to be looked at to all members of the board to be reviewed and adhered to.
