TOWN BOARD MEETING
March 21, 2023

The meeting was called to order at 7:02 pm by Supervisor Lewis.

Public Heard: Dana Sgrecci and his sister LuAnn O'Connell came in to discuss any regulations the Town of Catharine might have regarding the natural burial of their father on their property on Halpin Road.

RESOLUTION 16-2023

RESOLVE that the Town of Catharine sets the following requirements/criteria to allow for the natural burial of Louis Sgrecci on the family farm located on Halpin Road in the Town of Catharine: The burial site must be 25 feet from a property line, 100 feet from a well or water source, 50 feet from any septic tanks, and the location of the burial must be recorded on the property deed with a map attached.

Zoning Report: Rick Carroll stated that there were no new building permits for March. He did seven inspections; five were construction inspections and two were site inspections. He attended the meeting with the town's lawyer and Supervisor Lewis regarding the proposed zoning changes. He also attended the planning board meeting.

Rick is in the process of obtaining two inspection warrants for properties in the hamlet of Alpine. He had a couple of items for the planning board, including a proposed seasonal event business on State Route 228, and a question on zoning for the old Humane Society building on County Road 10.

Highway Superintendent's Report: Marty reported that they had done a dozen runs since the last meeting. The '04 blew a hydraulic line during the last storm. They've been patching holes on Steam Mill Road and Texas Hollow Road. The '97 Autocar has been taken out of service. The straps are rusting off, and it quit running. Marty pulled the tires off of the '97 and put them on the '79 Autocar. The Board members questioned Marty regarding how much the Town might get for the '97 Autocar; Marty said that he would include two old plows and a wing, and it has a stainless spreader. It could possibly go for \$10,000 or maybe more. The Town will advertise it and reserve the right to reject bids.

The grader had three flats and the spare was flat. The new pickup is coming in around April 22, and the loader is due for replacement. A new loader will be \$275,000; the last one was \$219,000. We would get \$225,000 for trade-in; and the new loader would come with a 2-year warranty.

Multi-Municipal Youth Group 2023 – The summer recreation program is due for renewal.

Dumpster Day – This year's dumpster day was discussed. Jamee Mack asked that we look into what it would cost to allow electronics to be included for next year's event. Volunteers for this event were requested.

Personnel policy – The board members discussed how many days or years of work are required for sick leave in regards to retirement. The current policy states that retiring employees who have accrued 90 days of sick leave can use that time to cover their continuation of health insurance coverage. It would take an employee approximately 9 to 10 years to accrue 90 days of sick leave.

Marty was asked to bring the exact pricing for his three proposed large equipment purchases before the Town Board. The board would then make resolutions for the bookkeeper to amend the budget to the amount required for these equipment purchases.
