

CATHARINE PARK RULES

- 1. Park hours are 8:00 AM through 10:30 PM.
- 2. No motorized vehicles on grass or off road.
- 3. No open campfires (All fires shall be in designated areas).
- 4. Use of Park is by "Permit Only" obtained from the Town Clerk or online at townofcatharine.com except for the Playground that is open to all.
- 5. No overnight camping.
- 6. The person whose name appears on the "Permit" is responsible for any damage incurred while using the Park.
- 7. ALL trash and garbage must be removed from the Park by the Permit Holder. CARRY IN / CARRY OUT. 24 Hour Video Surveillance.
- 8. Catharine Park is a SMOKE FREE ZONE.
- 9. Park Road speed limit is 15 MPH.
- 10. Dogs are welcome but you must clean up after your dogs.
- 11. **If you move any of the picnic tables**, please put them back where you found them (under the pavilion) before you leave. Thank you.

Please respect the rights of others and the property owners around the park by following the rules. The park is maintained for the use of area residents by the Town of Catharine Board. Please do your part by picking up after your group.
