Highway Superintendent's Report: Supervisor Lewis read the report provided by Marty. They have done a dozen plow and sand runs and have been doing shop work. There were a couple of dead trees that came down on Texas Hollow Road, and they have been removed. Marty provided a printout of the Cayutaville Road Bridge NY application and design submitted by Barton & Loguidice, D. P. C. The board members discussed the application and possible costs associated with the proposal.

Unfinished Business: ARPA Funds – The Town Clerk provided an update on the status of the projects using the remaining ARPA funds. The heat pump for the board room was installed and is working very efficiently. The painting project is due to be completed tomorrow. All funds have now been expended, and this will be reported during the annual reporting period in April.

Fire District – Supervisor Lewis and the members of the town board discussed the need for the formation of a fire district for the area, and the issues that were faced during the first attempt last year.

New Business: Budget Adjustments for 2024 – Glenn Bleiler discussed the proposed budget adjustments that were provided by the Town's Bookkeeper, Becki Wheeler. Glenn, and all of the board members, commended Becki Wheeler on the outstanding work she has done with the budget adjustments, and with the many other aspects of her job since she has started working for the Town of Catharine.
