TOWN OF CATHARINE TOWN BOARD MEETING April 15, 2025

The meeting was called to order at 7:03 pm by Supervisor Lewis.

Public Heard: Public Health Specialist Alyssa Morse discussed the programs provided by the Schuyler County Public Health department. She also discussed upcoming rabies clinics that will be held in the area this year.

Gary Emerson, Schuyler County Historian, came to thank the Town Board for their continued support of the Schuyler County Historical Society. He also discussed the Lawrence Chapel, and talked about the upcoming Open House/Tour on May 10th.

Minutes: Minutes were approved as read.

Highway Superintendent's Report: Marty reported that they have been taking care of downed trees and branches from the various windstorms, and filling in holes in the roads. The trucks are torn down and ready for summer work. They have borrowed the broom from the Town of Dix and are sweeping the roads. They replaced the front wing on the International, and replaced the broken blade on the grader. The dump motor on the Ram 5500 went bad and the scissor hoist broke loose as it was very poorly welded to begin with. Repairs have been completed on these. The '14 Pete is still at Wilbri waiting for the spreader chain. Marty will be working with Schuyler County Soil and Water on the 12th of next month to replace a pipe on Texas Hollow Road. The pipe there is collapsing. The town will be providing the materials, and Soil and Water will be providing the excavator and rocks for the project. There is no update for the Cayutaville Road project currently.

Marty discussed the proposed projects for this year's CHIPS funding.

RESOLUTION 25-2025

RESOLVE that the Town of Catharine approve the proposed CHIPS funding projects based on the CHIPS funding available being \$211,456.31.

Unfinished Business:

Fire District – Supervisor Lewis discussed an email he received from the Odessa fire chief; and stated that the fire chief wants to have a public meeting where no decisions will be made so that people came just come and get answers to their questions about the proposed fire district. It will be a casual discussion, and is planned for Wednesday, May 21st from 6 to 8 pm at the Odessa Fire Department. Everyone is encouraged to attend the meeting.

DEC (proposed land acquisition) – The town board members and members of the public present discussed the proposed acquisition of land near the Cayuta Lake Fishing Access Site. Concerns were expressed regarding the lack of support from the DEC for the current boat launch site, and the Town Clerk was asked to research the DEC website to find a contact person for the Town Board to send a letter to with concerns regarding the lake.

New Business:

Dumpster Day – The Town Clerk advised that this year's Dumpster Day will be held on May 17th from 9 – Noon, and requests volunteers to help during that time. The electronics recycling

truck will be available this year, and multiple companies were contacted for quotes for the dumpsters to lowers costs for this event.

Floating Business Zone (Fees/Application) – Tony Nevone provided a sample of an application for a Floating Business Zone, and the board members discussed the application. The board members were advised of the planning board's recommendation to change the requirement of the applicant bringing a licensed professional with a prepared site plan to the preliminary planning board meeting. The board members discussed the application, and decided to wait until May's meeting before deciding on what fees to charge for a Floating Business Zone application.

Cemetery Mowing (County Road 14 – Catharine Cemetery) – Councilmember Hoffman presented a proposal for mowing this cemetery that was provided by Heritage Memorial Mowing. The board members discussed the proposal, and a decision will be made at next month's board meeting.

Correspondence: A letter of resignation was received from Mike Scullin, the current chairperson for the Town's Assessment Review Board. The board members will try to find a replacement.

A request to change the date for May's board meeting was received from Councilmember Glenn Bleiler. The Town Clerk reminded the board members that some bills would be late due to the lateness of the proposed new meeting date. The Town Clerk will publish a legal notice regarding the changed meeting date.

RESOLUTION 27-2025

RESOLVE that the Town of Catharine's regularly scheduled board meeting for the Month of May shall be moved from May 20, 2025 to May 27, 2025, to accommodate Councilmember Glenn Bleiler's attendance; and the Town Board will allow the prepayment of up to \$500 on the town's credit card bill to avoid a late payment fee being charged to the town.
